1. The product specimens were entered for evaluation and type certification on 25.09.2017.
2. The Certificate was issued on the basis of documents provided by the client:
 - Application for certification from 25.09.2017
3. Detailed technical data characterizing the product type:

Description:	<p>Bungee trampoline 4 persons mobile can be installed repeatedly without damage or loss of integrity, temporarily or permanently, on the premises of fairgrounds, amusement parks and other locations.</p> <p>The structure consists of a steel module measuring 1700 x 1700 mm, made out of 80 x 40 x 2 mm sections. The module is set up on four height-adjustable supports. Four aluminium arms connected diameters of 90 and 80 mm and wall thickness of 3 mm extend from the module. The total height of the arms from ground level is 6900 mm. The peak span of the arms is 5400 mm. Trampolines with dimensions 3120 x 1730 mm, made out of steel 50 x 50 x 3 mm sections, can hold 4 persons. Entry to the trampolines is made through steps, or with the help of an operator. Persons inside protective harnesses are suspended with rubber cables measuring 10 mm in diameter and are raised up by an electric hoist with a capacity up to 250 kg.</p>

Supply voltage:	230 V / 50 Hz
